### **Minutes**

### Present: County & District

- 1. Apologies were received from Councillor Jones.
- 2. To receive and sign the minutes of the meeting held on Wednesday 9<sup>th</sup> October 2019 were received, approved and signed by the Chair.
- 3. Matters Arising:

Eleemosynary Accounts Request to Support Local Electricity Bill

School Admissions Policy – no changes that effect local schools

PCSO – Councillor Hibberd wrote to the PCSO regarding reports for the PC. The PCSO's do not routinely attend meetings or send reports unless there is a specific reason to do so. There is a website for PC's to download information. Where crime trends are identified PC's will be informed. There has been a recent burglary in the village. Lincs Alert no longer exists so the PC and local residents have not been informed. The platform most commonly used is Facebook which reaches a far wider audience, without the need to return to a police station.

4. Parish Matters:

Anglian Water – the fences are still to be repaired. The one on Chapel Lane is particularly bad. Clerk to send a further request to Anglian Water.

Trees – Mr Gamble will talk to his neighbour in order to agree that they maintain the trees. Church Sign – a larger sign to replace the current sign would be  $\pounds 120$ . PC agreed to fund. Lawnmower – reasons for volunteers not doing PC grass – insurance. Grass also needs to be taken away which is not currently possible.

5. County Councillor

A new CEO has been appointed – Debbie Barnes.

Call Connect Bus are running during the Christmas period until end of January – under 15's are free and anyone else is  $\pm 1.00$ .

Recycling – not to put in glitter, grub and grease. Further recycling discussed re food waste and glass. PC's feel further clarification required for parishioners as to what can be recycled.

6. District Councillor

Bin collection dates will alter over the holiday period – please visit the website. If you have green bin collection, Christmas trees can also be put out.

Meeting to discuss Tedder hall to be shut and a piece of land being bought in Horncastle instead. Decided to buy the land but no firm decision on Tedder Hall. The maintenance on Tedder Hall would buy the land in Horncastle over a number of years. Possibility of a shared community project. Loan to a caravan park – this is a business loan which comes with terms and penalties.

7. Planning:

Extension and alterations to the existing dwelling to provide a kitchen and wet room. 1 FEN FARM COTTAGES, FEN LANE, GRAINTHORPE, LOUTH, LN11 7JY – plans distributed prior to the meeting. No objections, application supported.

First floor extension to existing dwelling. DORERN DALE, POORS END, GRAINTHORPE, LOUTH, LN11 7JB – approved by circulation
